Dr. Mangino is one of ESP's foremost experts on data standards and systems architecture. She works directly with education agency clients on large scale projects and has developed several tools that help improve data management. She created ESP's *ISInsight™*, an ecosystem visualization template that is used to work with districts and states to conduct in-depth analysis of their data collections, repositories, and reporting tools. She also created ESP's *Disaster Prevention and Recovery (DPR) Planning Toolkit for School System Technology™*, designed specifically for school systems, for developing disaster recovery and business continuation plans.

With funding from the U.S. Department of Education, Dr. Mangino designed and conducted a study for the American Productivity and Quality Center (APQC) on the availability and use of student assessment data from state mandated tests. This study involved the development of survey instruments and interview protocols, and coordinating, scheduling, and conducting teacher and administrator interviews in seven states.

As part of the Education Data Exchange Network (EDEN) program of the U.S. Department of Education, Dr. Mangino designed data collection instruments and visited ten states to inventory and analyze data resources and capabilities to report education data. She also provided technical support to states in the initial year of EDEN/EDFacts reporting.

She coordinated communication to districts and trained on changes in data collection for precoding, correcting answer documents, and changes in assessment reports and interpretation. Dr. Mangino coordinated responses to ad hoc requests for information by SEA staff, districts, and external researchers. She also worked with various SEA departments to determine their information needs for accountability and evaluation purposes.
